(a) In addition to licensing racing, as hereinbefore provided, the Racing Commission is authorized to issue licenses to the following organizations: the Maryland State Fair and Agricultural Society, Incorporated shall be permitted to conduct a race meeting with betting privileges, not to exceed forty-two (42) days in any calendar year. Eighteen of the days assigned to the Maryland State Fair and Agricultural Society, Incorporated may be withdrawn by the Commission if the licensee fails to provide an improvement program prescribed by the Commission, but, if these days are withdrawn, they shall not be awarded elsewhere.
