(F) (E) EFFECTIVE ON JULY 1, 1984, EACH LICENSEE LICENSED UNDER THE PROVISIONS OF THIS SECTION AND HAVING A TOTAL WAGER IN EXCESS OF \$125,000 DAILY AVERAGE ON ALL RACES CONDUCTED BY IT SHALL ALLOCATE 0.25 PERCENT OF THE TOTAL OF ALL THE MUTUEL POOLS ON ALL RACES CONDUCTED BY IT DURING THE YEAR TO THE MARYLAND RACE TRACK EMPLOYEES PENSION FUND. MARYLAND HARNESS TRACK EMPLOYEES PENSION FUND TO BE ADMINISTERED BY REPRESENTATIVES OF THE LICENSEE AND THE EMPLOYEES.
