 County of York and for the better proceedings therein that they be charged with a
 Commission to Examine witnesses to prove the value of the lands and goods and Chattels that
 were in the possession of the said Benjamin Grainger at the time of the pronouncing of
 the said Decree and in whose hands custody or possession the same are now and by what
 right or title and when made and executed and for what Consideration and the said lands
 goods and Chattels for Seizure and Sequestration as aforesaid that they do deliver to the said
 Comptrolers for satisfaction of their Debt and Costs Debtor as aforesaid accordingly.
