 to them Dated as aforesaid this Court Hersonam and Chancery summae summe &
 fraudulent practices and being willing that the Doree of this Court shold be in vyable
 kept and performed and due obediencie given therunto doe order that a sequestration
 be issued accordingly directed to Maj^r Thomas Taylor and John Alford of the said
 County Grub and for the better prodding herein that they be Armed with a -
 Commission to Examinc witness to prove the value of the lands and goods and chattels that
 were in the possession of the said Benjamin Granger at the time of the pronouncing of
 the said Decree and in whose hands Custody or possession the same are now and by what
 right or title and when made and Executed and for what Consideration, And the said lands
 goods and chattels for seized and sequestred as aforesaid that they doe deliver to the said
 Compt^t for satisfaction of their debt and costs Dated as aforesaid accordingly.
