the affidavitt of our said Comptt John Haslwood and the returnew of y<sup>e</sup> process aforesaid to the  
great hinderance of the Comptt in the execution and performance of the will of the said  
John Drury and therefore it was prayed that first the said Benjamin Granger was fforde out of  
the jurisdiction of our said Court that our writt of sequestration might beawardod to have justit  
of y<sup>e</sup> p[ar]te of our said County of Dorset for County directed to enter into foizt and sequester into  
their hands and possession of Land goods and Cattell of him the said Benjamin Granger  
in the actual possession of him the said Benjamin Granger in his owne ex righte  
at the time of his madnes and quonwering of the said Dorre be the same in the  
hands and custody or possession of the said John Gostard or of any other person or  
persons whatsoevr and the same be entred upon foizt and sequestered as aforesaid  
the same lands goods and Cattell to the said John Haslwood and his wife to deliver  
for the fullffaction of their said debt and cost of suete to them dorred as aforesaid  
whereupon our said Court abhorring such Clendfing and fraudulent practices &  
being willing that the Dorets of our said Court should be inviolably kept ex forme  
and due obediencie given therewto did ordene that our said writt of Sequestration  
dat ymme accordingly directed to you Thomas Taylor and John Elford and for your  
better procedyngs therein that you shalbe armed with our Commission to Examyn wittnesses  
to prove the value of y<sup>e</sup> lands and goods and chattel that were in the possession of the  
said Benjamin Granger at the time of the quonwering of the said Dorre and in  
whiche hands Custody or possession the same are now and by what right or title and  
when made and Executed and for what Consideration & the goods & Cattell for fforde  
and sequestred as aforesaid that you do deliver to the said Comptt for fullffaction of  
their debt and costs dorred as aforesaid accordingly How know yee that wee trussting  
to your fidelites and prudent circumfpectione haue assigned you and by virtue  
of this p[ro]c[ess] do give unto you full power and authority to enter upon fforde  
and take y<sup>e</sup> possession all the lands goods Cattell and chattell that were in the possession  
of him the said Benjamin Granger at the time of the making and pronouning of the  
said Dore to wit upon the said scameleous day of October one thousand six  
hundred seavenyng daies and the same bequestred the same to deliver to the possession of  
the said Comptt for fullffaction of their debt of twenty four pounds sterl[ing] and  
three thousand three hundred fifty and ffe yowndes of tobaccoe to them dorred as  
aforesaid and for your better procedyng in the premises we do hereby give  
unto you the full power and authority of enquiring as well by the Depositions and  
Examynacions of certaine wittnesses to be produced and Examined before you as by any  
other manner or way by which the truth of the premises may be the better found out  
and discoured as to you shall seeme neede what lands goods Cattell and chattell the said  
Benjamin Granger was fforde or possessed of at the said day of quonwering the
