Alexand Cambell aged 39 years being sworn upon y^e
holy Evangelists faith
That y^e Depl being at y^e house of Mr Thomas Jervis about
3 or 4 years ago Mr Horman & Mr Dard had some discourse
about Tho Howes and he heard Mr Horman say to y^e Depl
Wm Dard why did he not make an order with y^e Depl Tho Howes
about y^e land & severall other words passed between them to y^e
effect Tho Howes Mr Horman told y^e Depl y^e Howes but y^e Depl
his tob house he would pay him there for y^e Howes but y^e Depl
Dard refused Upon with Mr John Thompson being present he
y^e Depl offered to lend Coll Horman as much ready tob
as he should have occasion for to satisfy Mr Dard upon y^e acct
of Tho Howes but y^e Depl would not accept of it Upon
Mr Horman replyd y^e he would stand by & help y^e poor Man
Tho Howes & farther y^e Depl faith not Alex Cambell
Sworn this 20 day of July 1695
