 estate of Inheritance of in & to two severall tracts or
 parcels of Land in yo^r County yo^r mo^r called the Indian Range & contain
 ing two hundred Acres, yo^r other being yo^r Remaind of a tract of
 Land formerly belonging unto one Godfrey Horman but then vested
 in yo^r John Polerson & yt pursuant to yo^r Communication & agreement
 aforesaid he yo^r M^r Morcor did satisfy & pay unto yo^r John Polerson
 a sum or quantity of ten thousand pounds of Tobacco. yet not-
 withstanding such payment yo^r John Polerson utterly refused &
 denied to make over or convey yo^r two tracts of Land unto yo^r M^r
 Morcor pursuant to yo^r agreement aforesaid. To all which Complain-
 t yo^r John Polerson makes no other Answer than yt at yo^r time of
 making yo^r Agreement he was under yo^r age of one & twenty years
 as also yt he had not received from yo^r M^r Morcor yo^r Consideration
 of ten thousand pounds of Tobacco nor any part or parcel thereof
 as well yo^r M^r Morcor replies yt yo^r John Polerson at yo^r time of yo^r Com-
 munication & agreement aforesaid was of full Age, as also yt he had fully
 satisfied & paid unto yo^r John Polerson yo^r ten thousand pounds of Tobacco
 aforesaid upon hearing of which bill Answer & Application as also of
 all yo^r proofs testimonies & depositions of both sides relating to yo^r pro-
 cess, as likewise of yo^r pleadings & allegations of yo^r Council as
 well on yo^r part of yo^r Complainant & on yo^r part of yo^r doct before
 Coll Henry Jones Mayor of our great seal in our s^d province
 & his associates it was evidently made appear yt at yo^r time of yo^r
 Communication aforesaid yo^r John Polerson was of yo^r age of twenty & one
 years & yt soon after yo^r Communication & agreement yo^r M^r Morcor
 Complainant had fully & completely satisfied & paid unto
 yo^r John Polerson yo^r doct yo^r sum of ten thousand pounds of Tobacco
 for & in consideration of yo^r two tracts of Land aforesaid Where-
 fore it is hereby adjudged sentenced & decreed yt yo^r John Polerson
 yo^r doct do make over convey & confirm unto yo^r M^r Morcor
 a firm estate of Inheritance in & to yo^r two tracts of Land in
 the simple by such words or words as yo^r doct shall by his Coun-
 sel learned in yo^r Law get prepared for yo^r purposes at any time
 before yo^r first day of October next & yt he acknowledge yo^r same
 according to Act of Assembly of this province in such Cases
 made & provided, & farther yt he pay unto yo^r said Thomas
 Morcor yo^r neat quantity of Two thousand and thirty
 pounds of Tobacco for his cost & charges in this behalf laid out
 & taxed by our s^d Court all which he is in no wise to omit
