Deposition for Ambrose Lammont
 20th July 1698

By virtue of a Commission to His Excellent Majesty's Court of
 Chancery We have called before us John Newman of
 Talbot County plant^r aged about fifty six years in perfect
 health & did make oath before us y^t about thirty three or thirty
 four years ago he put in for a lease with one John Knight
 y^t lived upon a piece of Land in Woods Creek in Michael's
 River in Talbot County And as he was clearing a piece of
 Ground y^t John Knight came to him & showed him a bounded
 tree & cautioned him not to fall y^t tree telling him it was
 his bounded tree well to y^e best of his remembrance was
 a Cedar but what was y^e name of y^e tract of Land y^t
 John Knight then lived on or well was y^e then reported
 mouth of Woods Creek this Dept^r knoweth not but as to
 y^e place where y^e bounded tree stood this Dept^r knoweth
 very well remembrance y^t it stood upon y^e lower side of a
 Marsh now a piece of clear Ground where there stood a
 tobacco house & further south y^t being lately upon y^e side
 y^t formerly belonged to & was in y^e possession of y^e said John
 Knight he saw y^e Post of a tobacco house & well verily
 believe these posts to be y^e posts of y^e tobacco house before
