 demanded what the Company were inclined to do, who was answered they  
 were willing he then concluded to go and immediately weighed, then again  
 heartily begged for my Sloop and men after much Intreaty the Cap: orderd  
 me my boat but not my men he then being under Sails I went on Board  
 my Sloop with what men he had left me and after I had left one Mr. Pope  
 a Merchant on board the Schoon who had been detained on Board of Pyrats  
 I then stood right up the Bay for the Ports of Annapolis in Maryland  
 and immediately upon my Arrival there I made my Application to his  
 Ex: the Governour gave his Ex: an Acc: of what had happened was by  
 his Ex: directed to an Officer to whom I made Reports, after which I went  
 on Board my Sloop with my men and then I called over all my Goods  
 and found wanting the severall Goods & Commodities hereafter mentioned

These severall Goods hereafter mentioned taken by the Pyrats  
 from on Board the Sloop Cranock Merch: that is to say

- 16 Barrells of Pork
- 1 Barrell of Tallow
- 29 Bushells of Beans
- 2 Quils of Ropes
- 6 Firelocks w: all our Ammunition  
 with of our Carpenters tools  
 and diverse household Utensils  
 for use
- 2 Barrell of Carr & Balls of  
 Ropes for use long line & kool

- Small Cask of Water
- a quantity of Provision
- By w: abt 30 or 40 Bushells of  
 Corn was damped & fell my  
 down to y<sup>e</sup> bottom of the Sloop
- Likewise one Barrell marked  
 belonging to one Mr. Rob: Mollon  
 a Passenger
- 1 Dry Hide, 4 raw Deer  
 & one Beaver Skin
