assigned to him by Howell as pay for plank, flooy, live &  
other matters of by a particular acct at ye issue between  
them follow And ye 30 Articles did fully pay but not over  
- pay ye debt on acct from Howell to Fishburn therefore  
ye Court allows this Article } 50 11 00

5<sup>th</sup> The Court allows ye 5<sup>th</sup> Article } 30 00 00  
6<sup>th</sup> And also ye sixth } 03 00 00

7<sup>th</sup> Upon ye 7<sup>th</sup> ye Ct allows 4 Articles for ye 12 Articles  
(because it was but bulk tobacco) & no more for ye by a  
Letter from Howell to Fishburn date ye 1<sup>st</sup> of ye  
Eleventh month 1692 it appears ye tobacco ye had was  
sold at 9<sup>0</sup> 1/2 & 9<sup>0</sup> 3/4 per po out of ye ship at ye port  
of Newcastle: And likewise because it appears by a Receipt  
under Howell's hand date June 14 1692 ye ye  
Howell had recd ye 12 Articles in this 7<sup>th</sup> art. viz<sup>t</sup> } 48 00 00

8<sup>th</sup> The 8<sup>th</sup> Article is rejected by ye Court } 00 00 00  
9<sup>th</sup> The ninth is allowed } 72 09 06

10<sup>th</sup> On ye tenth Fishburn attests ye Howell actually received 22 of ye 28  
Articles sold him but doubting whether he received ye other 6 Articles ye Ct  
allows ye 22 Articles & no more according to ye bill of Lading re-  
ported by ye Audit & viz<sup>t</sup> } 55 00 00

11<sup>th</sup> The Ct allows in this Article - only - - - } 05 00 00  
12<sup>th</sup> The 12<sup>th</sup> is allowed by ye Ct } 12 08 00

13<sup>th</sup> &c And so are all ye following Articles to ye 22 inclusive all at } 22 03 06  
14<sup>th</sup> The 23<sup>rd</sup> is rejected } 433 13 04

15<sup>th</sup> And also ye 24<sup>th</sup> for ye Reasons why it was rejected by ye Audit }
