

464) Mary Cantell Whoredas heretofore (if it to say upon ye 27th day of June An^o 1700 William Guyther of St. Marys County gent^l exhibited by bill of complaint to yo^r high Court of Chancery against Edward Gley of yo^r County gent^l to be relieved against a false facias issued at yo^r suit of yo^r Gley as yo^r Guyther upon a judgment obtained at yo^r Gley for two thousand five hundred twenty five pounds of tobacco & five hundred fifty seven pounds of tobacco of yo^r Gley just Whoredas indeed all yo^r forsaide tobacco was paid to yo^r Gley (before yo^r facias issued) by one Joshua Boyce of yo^r County gent^l by order of yo^r Guyther as by yo^r bill of complaint doth appear And Whoredas yo^r Guyther did thereby obtain his writ of Injunctⁿ to stay all proceedings on yo^r facias till yo^r matter should be heard in Equity; Whoredas yo^r Gley coming to hearing in this his Majesty's Court of Chancery upon yo^r doleth day of July An^o 1701 yo^r Court did & doth thereupon decree That yo^r complaint & Guyther shall be relieved & yo^r Guyther shall be relieved to his prayers in his bill And yo^r Court of Chancery have from yo^r Gley all his costs in yo^r Court of Chancery allowing to yo^r Gley all his costs in yo^r Provincial Court & Costs of yo^r facias
