By Virtue of a Commission out of her Majesty's high Court of Chancery bearing date ye 17th day of July last, continuing W<sup>m</sup> Hutchinson & Robert Middleton to take ye Deposition of such Evidences as Mr Charles ~~John~~ <sup>John</sup> should call before us concerning ye bounds & bound Trees of a certain tract of five thousand Acres of Land called Mathawoman Neck in the County of Anne Arundel We have Examined Matthew Jancort aged about Sixty years who having taken his Oath & sworn truly to say what he knows & believes he did declare that about thirty three years ago he was informed by one Mr Hollingsworth then owner of ye said Neck & was of ye same & by one W<sup>m</sup> Boyden told this Dep<sup>o</sup> by him was produced ye Resurvey of ye Neck begun at a branch called the top branch near to Parunkoy Town against an Island in Potomack River known to them by the Name of Neumps Island & ye Boyden told this Dep<sup>o</sup> by Mr Thomas Allison standing for same branch to Mr Hollingsworth for his beginning this Dep<sup>o</sup> being asked how he knew ye S<sup>d</sup> branch to be ye place Boyden meant of did declare ye Boyden & he has been several times at it before ye Resurvey & knew by ye Name of ye S<sup>d</sup> branch but never since to ye best of his Memory that a certain Mr Middleton do declare ye Neck Land Mr Allison say ye S<sup>d</sup> Island Neck begun at a tree opposite to ye Island which is all ye Evidence ye appeared to us concerning either ye bounds or ye bound Trees of ye said Neck of Land We being then present at ye supposed place above mentioned for ye beginning of ye Land Given under our hand & Seal this twenty sixth day of July Anno Dom 1706
