SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- (A) THERE IS A BLUE RIBBON COMMISSION TO STUDY RETIREE HEALTH CARE FUNDING OPTIONS.
 - (B) THE COMMISSION SHALL CONSIST OF THE FOLLOWING MEMBERS:
- (1) FOUR <u>THREE</u> MEMBERS FROM THE SENATE OF MARYLAND, APPOINTED BY THE PRESIDENT OF THE SENATE, INCLUDING:
- (I) <u>THE SENATE CHAIR OF THE JOINT COMMITTEE ON PENSIONS;</u>
 AND
- (II) THREE TWO MEMBERS FROM AMONG THE MEMBERS OF THE JOINT COMMITTEE ON PENSIONS; AND
- (II) ONE MEMBER FROM AMONG THE MEMBERS OF A STANDING COMMITTEE THAT CONSIDERS STATE PERSONNEL ISSUES:
- (2) FOUR THREE MEMBERS FROM THE HOUSE OF DELEGATES, APPOINTED BY THE SPEAKER OF THE HOUSE, INCLUDING:
- (I) <u>THE HOUSE CHAIR OF THE JOINT COMMITTEE ON PENSIONS;</u>
 AND
- $\underline{\rm (II)}$ $\,$ Three $\underline{\rm TWO}$ Members from among the members of the Joint committee on pensions; and
- (II) ONE MEMBER FROM AMONG THE MEMBERS OF A STANDING COMMITTEE THAT CONSIDERS STATE PERSONNEL ISSUES;
 - (3) THE STATE TREASURER, OR THE TREASURER'S DESIGNEE;
 - (4) THE COMPTROLLER, OR THE COMPTROLLER'S DESIGNEE;
- (5) THE SECRETARY OF BUDGET AND MANAGEMENT, OR THE SECRETARY'S DESIGNEE;
- (6) THE CHANCELLOR OF THE UNIVERSITY SYSTEM OF MARYLAND OR THE CHANCELLOR'S DESIGNEE;
