A RESOLUTION OF THE CITY OF GREENBELT, MARYLAND, TO AMEND SECTION 2 OF THE CHARTER OF THE CITY OF GREENBELT, FOR THE PURPOSE OF ENLARGING THE CORPORATE BOUNDARIES OF THE CITY OF GREENBELT, MARYLAND, UNDER THE PROVISIONS OF ARTICLE 23A, SECTION 19, OF THE ANNOTATED CODE OF THE STATE OF MARYLAND (1957 EDITION AND AMENDMENTS), BY ANNEXING THERETO CERTAIN LANDS AND PROPERTY CONTIGUOUS TO AND ADJOINING THE EXISTING CORPORATE BOUNDARY OF THE CITY OF GREENBELT, PRINCE GEORGE'S COUNTY, BEING THE LANDS OF THE STATE OF MARYLAND, LOCATED WITHIN BERWYN DISTRICT 21, PRINCE GEORGE'S COUNTY, MARYLAND, AND CONSISTING OF PRINCE GEORGE'S COUNTY TAX MAP 26, PARCEL 93 AS LISTED IN THE ASSESSMENT AND TAXATION RECORDS OF THE STATE OF MARYLAND, AND AS RECORDED AMONG THE LAND RECORDS OF PRINCE GEORGE'S COUNTY, MARYLAND, IN LIBER 14327 FOLIO 351 AND CONTAINING 75.4634 ACRES MORE OR LESS, AS MORE FULLY DESCRIBED IN THE METES AND BOUNDS DESCRIPTION PREPARED BY JOYCE ENGINEERING, INC; ESTABLISHING CERTAIN TERMS, CONDITIONS, AND CIRCUMSTANCES APPLICABLE TO SUCH LAND AND THE OWNERS THEREOF; AND ALL MATTERS RELATING TO THE ANNEXATION OF SUCH 75.4634 ACRES OF LAND, MORE OR LESS, INTO THE CITY OF GREENBELT
