CHARTER RESOLUTION NO. 250

A RESOLUTION BY THE MAYOR AND CITY COUNCIL OF HAVRE DE GRACE, MARYLAND, ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE XI-E OF THE CONSTITUTION OF MARYLAND AND THE PROVISIONS OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (WEST 2002 and 2005 SUPPLEMENT, AND ANY AMENDMENTS THERETO) TITLED "CORPORATIONS-MUNICIPAL;" TO AMEND SECTION 19 OF THE CHARTER OF HAVRE DE GRACE, MARYLAND, TO PROVIDE THAT ANY RESOLUTION OR ORDINANCE NOT ENACTED WITHIN ONE HUNDRED EIGHTY (180) DAYS AFTER ITS INTRODUCTION SHALL BE DEEMED TO HAVE FAILED.
