## SALISBURY

CITY GENERAL TAX REVENUES OUTSTANDING AT THE TIME ANY SUCH BONDS ARE ISSUED SHALL NOT EXCEED AN AMOUNT EQUAL TO FOUR PERCENT OF THE ASSESSED VALUATION OF ALL REAL PROPERTY SUBJECT TO TAXATION BY THE CITY PLUS TEN PERCENT OF THE ASSESSED VALUATION OF ALL PERSONAL, CORPORATE AND UTILITY PERSONAL PROPERTY SUBJECT TO TAXATION BY THE CITY, AND TO EXCLUDE CITY BONDS (OTHER THAN GENERAL OBLIGATION BONDS) ISSUED PURSUANT TO THE TAX INCREMENT FINANCING ACT FROM THE CALCULATION OF SUCH DEBT LIMIT; PROVIDING THAT THIS TITLE IS A FAIR SUMMARY OF SUCH CHARTER AMENDMENTS; AND PROVIDING FOR THE PROCEDURES TO BE FOLLOWED FOR THE EFFECTIVENESS OF THIS CHARTER AMENDMENT RESOLUTION.
