(IV) (VI) THREE SHALL BE INDIVIDUALS WHO HAVE A BACKGROUND OR EXPERIENCE WITH A COMMUNITY HEALTH RESOURCE WITHIN THE PAST 5 YEARS.

(3) AT LEAST TWO OF THE NINE ELEVEN MEMBERS SHALL BE HEALTH CARE PROFESSIONALS LICENSED IN THE STATE.

~~(6) A MEMBER WHO SERVES TWO CONSECUTIVE 4 YEAR TERMS MAY NOT BE REAPPOINTED FOR 4 YEARS AFTER COMPLETION OF THOSE TERMS.~~

~~(7) (B) TO THE EXTENT PRACTICABLE, WHEN APPOINTING MEMBERS TO THE COMMISSION, THE GOVERNOR SHALL ASSURE GEOGRAPHIC BALANCE AND PROMOTE RACIAL AND GENDER DIVERSITY IN THE COMMISSION'S MEMBERSHIP.~~
