AN ACT concerning

Motor Vehicles - Low Speed Vehicles - Standards and Restrictions

FOR the purpose of clarifying that the Motor Vehicle Administration may issue certificates of title for, and register, certain low speed vehicles; providing for the classification of low speed vehicles; establishing an annual registration fee for low speed vehicles; requiring the application for registration of low speed vehicles to be submitted electronically; requiring a licensed dealer of low speed vehicles under certain circumstances to obtain a low speed vehicle registration application from the vehicle's owner, collect registration fees, and transmit the
