(House Bill 709)

AN ACT concerning

Secretary of Agriculture – Regulation of Poultry to Control Avian Influenza

FOR the purpose of requiring certain live poultry markets, poultry production facilities, and poultry dealers to obtain a certain annual license; authorizing the Secretary of Agriculture to adopt a certain animal health protection program; prohibiting certain persons from keeping poultry unless the persons register with the Secretary; requiring a person who keeps poultry to complete and submit to the Secretary a certain registration form; requiring the Secretary to maintain certain registration records in a certain manner that protects the identity of the registrant; authorizing the disclosure of certain ~~registration~~
