SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article 4 – Baltimore City

21-17.

(a) (1) In this section the following words have the meanings indicated.

(2) “Abandoned property” means:

(i) an unoccupied structure or vacant lot on which taxes are in arrears for at least 2 years;

(ii) a building:

- 1. that is unoccupied by owner or tenant;
- 2. that is unfit for habitation;
- 3. that has deteriorated to the point where:
 - A. the building is structurally unsound; or
