SUBTITLE 21. MARYLAND COMMUNITY HEALTH RESOURCES COMMISSION.

(A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

(B) "COMMISSION" MEANS THE MARYLAND COMMUNITY HEALTH RESOURCES COMMISSION.

(C) (1) "COMMUNITY HEALTH RESOURCE" MEANS A NONPROFIT OR FOR PROFIT HEALTH CARE CENTER OR PROGRAM THAT OFFERS THE PRIMARY HEALTH CARE SERVICES REQUIRED BY THE COMMISSION UNDER § 19-2108(A)(2) OF THIS SUBTITLE TO AN INDIVIDUAL ON A SLIDING SCALE FEE SCHEDULE AND WITHOUT REGARD TO AN INDIVIDUAL'S ABILITY TO PAY.

(2) "COMMUNITY HEALTH RESOURCE" INCLUDES:

- (I) A FEDERALLY QUALIFIED HEALTH CENTER;
- (II) A FEDERALLY QUALIFIED HEALTH CENTER "LOOK-ALIKE";
- (III) A COMMUNITY HEALTH CENTER;
- (IV) A MIGRANT HEALTH CENTER;
- (V) A HEALTH CARE PROGRAM FOR THE HOMELESS;
- (VI) A PRIMARY CARE PROGRAM FOR A PUBLIC HOUSING PROJECT;
- (VII) A LOCAL NONPROFIT AND COMMUNITY-OWNED HEALTH CARE PROGRAM;
- (VIII) A SCHOOL-BASED CLINIC HEALTH CENTER;
- (IX) A TEACHING CLINIC FOR HEALTH CARE PROFESSIONALS NOT LOCATED IN SPACE REGULATED BY THE HEALTH SERVICES COST REVIEW COMMISSION;
- (X) A WELLMOBILE;
- (XI) A HEALTH CENTER CONTROLLED OPERATING NETWORK; ~~AND~~
- (XII) A HISTORIC MARYLAND PRIMARY CARE PROVIDER;
- (XIII) AN OUTPATIENT MENTAL HEALTH CLINIC; AND
- ~~(XIV)~~ (XIV) ANY OTHER CENTER OR PROGRAM IDENTIFIED BY THE COMMISSION AS A COMMUNITY HEALTH RESOURCE.
