A RESOLUTION BY THE MAYOR AND CITY COUNCIL OF HAVRE DE GRACE, MARYLAND, ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE XI-E OF THE CONSTITUTION OF MARYLAND AND THE PROVISIONS OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION AND AMENDMENTS THERETO) TITLED "CORPORATIONS-MUNICIPAL"; TO AMEND THE APPENDIX OF THE CHARTER OF THE MAYOR AND CITY COUNCIL OF HAVRE DE GRACE, MARYLAND, BY ADDING A NEW SUBSECTION A. 23 ENTITLED "THE 2004 ADDITION TO THE CITY BOUNDARIES," ENLARGING THE BOUNDARIES OF THE CITY OF HAVRE DE GRACE BY ANNEXING LAND OWNED BY GREENWAY INVESTMENTS, LLC, MID-ATLANTIC COOPERATIVE SOLUTIONS, INC., 1715 PULASKI, LLC, AND CSX RAILROAD, AND CONSISTING OF 150 ACRES, MORE OR LESS, WHICH IS CONTIGUOUS TO AND ADJOINING THE WESTERN BOUNDARY OF THE EXISTING CORPORATE AREA OF THE CITY OF HAVRE DE GRACE.
