Bill No. 2004-18

AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND, TO ADOPT NEW ARTICLE XIV AND NEW SECTION 155-71 TO CHAPTER 155 OF THE DORCHESTER COUNTY CODE TO PROVIDE REGULATIONS PERTAINING TO DEVELOPMENT RIGHTS AND RESPONSIBILITIES AGREEMENT AS AUTHORIZED UNDER ARTICLE 66B OF THE ANNOTATED CODE OF MARYLAND, SECTION 13.01 AND TO DEFINE TERM "AGREEMENT" IN THE COUNTY ZONING ORDINANCE.

AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND, TO AMEND CHAPTER 155, SECTION 155-38. N. OF THE DORCHESTER COUNTY CODE TO PROVIDE CLEARER GUIDELINES REGARDING GROWTH ALLOCATION PROCESS FOR MUNICIPAL AND NON-MUNICIPAL REQUESTS AS WELL AS DEFINING THE TERMS "MUNICIPAL INFILL GROWTH ALLOCATION", "MUNICIPAL ANNEXATION GROWTH ALLOCATION", AND "SUPPLEMENTAL GROWTH ALLOCATION".

AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND, TO AMEND CHAPTER 155, SECTION 155-50. Q.2. OF THE DORCHESTER COUNTY CODE TO PROVIDE THAT FAMILY DAY CARE IS DELETED FROM HOME OCCUPATION SPECIAL EXCEPTION LIST AND ADDED UNDER THE TABLE OF PERMITTED USES.

AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY, MARYLAND, TO AMEND CHAPTER 155, SECTION 155-6. A. OF THE DORCHESTER COUNTY CODE TO PROVIDE THAT APPLICANTS FOR ZONING REQUESTS ARE RESPONSIBLE FOR POSTING OF PUBLIC NOTICE SIGNS INSTEAD OF THE DIRECTOR OF PLANNING.

AN ACT OF THE COUNTY COUNCIL OF DORCHESTER COUNTY MARYLAND PURSUANT TO CHAPTER 144, SECTION 144-32 OF THE DORCHESTER COUNTY CODE AND PURSUANT TO ARTICLE 25-A, SECTION 5(S) OF THE ANNOTATED CODE OF MARYLAND, ADDING NEW SECTION 155-20.1 TO CHAPTER 155 OF THE DORCHESTER COUNTY CODE, GRANTING AUTHORITY TO THE BOARD OF ZONING APPEALS TO HEAR AND DECIDE APPEALS FROM THE DECISION OF THE DIRECTOR OF PLANNING REGARDING THE CALCULATION OF THE AMOUNT OF THE BUILDING EXCISE TAX UNDER CHAPTER 144 OF THE DORCHESTER COUNTY CODE.
