Martin, has the greatest number of legal votes for Judge of the Superior Court of Baltimore city; that John C. King, has the greatest number of legal votes for Judge of the Court of Common Pleas; that Hugh L. Bond, has the greatest number of the legal votes for Judge of the Criminal Court of Baltimore city; that J. Thomas Adams, has the greatest number of legal votes for Clerk of the Circuit Court for Baltimore city; that James D. Lowry, has the greatest number of legal votes for Clerk of the Court of Common Pleas; that Gilbert H. Bryson, has the greatest number of legal votes for Surveyor; that Frederick Fickey, Jr., has the greatest number of legal votes for Commissioner of Public Works; that Edward R. Sparks, had seventeen thousand eight hundred and twelve ballots, and Charles Towson, had three thousand three hundred and twenty-eight ballots, and G. Zimmerman, had one ballot for shereiff.

Whereupon, we so determine, declare and return that the said William Price, Michael Warner, James Stockdale, Edmund Wolf, Thomas S. Alexander, R. Stockett Mathews, Nicholas Christopher, Jacob W. Hugg, Steptoe B. Taylor, William S. Reese, Morris Cochran, Robert N. Martin, John C. King, Hugh L. Bond, J. Thomas Adams, James D. Lowry, Gilbert H. Bryson and Frederick Fickey, Jr., are duly elected; and that Edward R. Sparks and Charles Towson, had a majority of the legal ballots of the candidates for Sheriff, properly qualified.
