- (A) AS USED IN THIS SECTION "STATE SERVICE" MEANS SERVICE WITH THE STATE AS AN EMPLOYEE, JUDGE, TEACHER, OR CORRECTIONAL OFFICER AS DEFINED IN ARTICLE 73B, §§ 1(3), 55(F), 81(3), 111(4), 140(4), AND 156(A), AND ARTICLE 88B, § 49(3).
- (B) A BENEFICIARY, AS DEFINED IN ARTICLES 73B AND 88B, AND THEIR DESIGNATED BENEFICIARIES, OTHER THAN DESIGNATED BENEFICIARIES NOMINATED TO RECEIVE AN OPTION 4 BENEFIT, MAY PARTICIPATE, AS PROVIDED BY THIS SECTION, IN THE STATE EMPLOYEES HEALTH INSURANCE PROGRAM PROVIDED THAT THE BENEFICIARY:
