(1) 8 SHALL BE HANDICAPPED INDIVIDUALS;

(A) THE TERM OF A MEMBER OF THE COUNCIL IS 3 YEARS.

(B) THE TERMS OF THE MEMBERS ARE STAGGERED AS REQUIRED BY  
THE TERMS PROVIDED FOR MEMBERS OF THE COUNCIL ON JULY 1, 1984.

(C) AT THE END OF A TERM, A MEMBER CONTINUES TO SERVE UNTIL  
A SUCCESSOR IS APPOINTED AND QUALIFIES.

(D) A MEMBER WHO IS APPOINTED AFTER A TERM HAS BEGUN SERVES  
ONLY FOR THE REST OF THE TERM AND UNTIL A SUCCESSOR IS APPOINTED  
AND QUALIFIES.

(E) A MEMBER MAY NOT SERVE CONSECUTIVELY MORE THAN 2 3-YEAR  
TERMS.

(F) ANY MEMBER WHO FAILS TO ATTEND AT LEAST 50 PERCENT OF  
THE REGULARLY SCHEDULED MEETINGS DURING ANY 12 MONTH PERIOD SHALL  
BE CONSIDERED TO HAVE RESIGNED.
