4-506. PROTECTIVE ORDERS.

## (A) HEARING.

- A HOUSEHOLD MEMBER SERVED WITH A TEMPORARY EX PARTE ORDER UNDER § 4-505 OF THIS SUBTITLE SHALL HAVE AN OPPORTUNITY TO BE HEARD ON THE QUESTION OF WHETHER THE COURT SHOULD ISSUE A PROTECTIVE ORDER.
  - (B) DATE AND TIME OF HEARING.
- (1) THE TEMPORARY EX PARTE ORDER SHALL STATE THE DATE AND TIME OF THE PROTECTIVE ORDER HEARING.
- (2) THE PROTECTIVE ORDER HEARING SHALL BE HELD NO LATER THAN 5 DAYS AFTER THE TEMPORARY EX PARTE ORDER IS SERVED ON THE HOUSEHOLD MEMBER NAMED AS AN ABUSER IN THE TEMPORARY EX PARTE ORDER.
  - (C) FAILURE TO APPEAR.
- IF THE HOUSEHOLD MEMBER NAMED AS AN ABUSER IN THE TEMPORARY EX PARTE ORDER IS SERVED THE TEMPORARY EX PARTE ORDER AND FAILS TO APPEAR FOR THE PROTECTIVE ORDER HEARING, THE COURT MAY CONTINUE THE TEMPORARY EX PARTE ORDER FOR NOT MORE THAN 15 DAYS.
  - (D) ISSUANCE OF PROTECTIVE ORDER.
- IF THE HOUSEHOLD MEMBER NAMED AS AN ABUSER IN THE TEMPORARY EX PARTE CADER APPEARS FOR THE PROTECTIVE ORDER HEARING AND IF THE COURT FINDS BY CLEAR AND CONVINCING EVIDENCE THAT THE ALLEGED ABUSE HAS OCCURRED, THE COURT MAY GRANT A PROTECTIVE ORDER TO STOP THE ABUSE.
  - (E) CONTENTS OF PROTECTIVE ORDER.

THE PROTECTIVE ORDER MAY:

- (1) ORDER THE ALLEGED ABUSER TO REFRAIN FROM ABUSING HOUSEHOLD MEMBERS;
- (2) ORDER THE ALLEGED ABUSER TO VACATE THE FAMILY HOME IMMEDIATELY AND GRANT TEMPORARY POSSESSION OF THE FAMILY HOME TO THE PETITIONER FOR NOT MORE THAN 15 DAYS;
- (3) AWARD TEMPORARY CUSTODY OF A MINOR HOUSEHOLD MEMBER;
- (4) DIRECT ANY OR ALL OF THE HOUSEHOLD MEMBERS TO PARTICIPATE IN A PROFESSIONALLY SUPERVISED COUNSELING PROGRAM; AND
