10-324. ADDITIONAL POWERS OF COURT.

IN ADDITION TO ANY OTHER POWERS SET FORTH IN THIS SUBTITLE, A COURT OF THIS STATE, WHEN THIS IS THE RESPONDING STATE, MAY SUBJECT THE OBLIGOR TO THE TERMS AND CONDITIONS THAT THE COURT DEEMS PROPER TO ASSURE COMPLIANCE WITH ITS ORDERS AND IN PARTICULAR MAY:

- (1) REQUIRE THE OBLIGOR TO PROVIDE RECOGNIZANCE IN THE FORM OF A CASH DEPOSIT OR BOND OF A CHARACTER AND AMOUNT PROPER TO ASSURE PAYMENT OF ANY AMOUNT DUE;
- (2) REQUIRE THE OBLIGOR TO MAKE PAYMENTS AT SPECIFIED INTERVALS TO THE CLERK OF THE COURT, THE ADMINISTRATION, OR OTHER DESIGNATED LOCAL AGENCY FOR THE PURPOSE OF COLLECTING PAYMENTS OF THE OBLIGOR AND TO REPORT PERSONALLY TO THE CLERK, THE ADMINISTRATION, OR THE LOCAL AGENCY AS THE COURT MAY DIRECT; AND
- (3) PUNISH AN OBLIGOR WHO VIOLATES ANY ORDER OF THE COURT TO THE SAME EXTENT AS PROVIDED BY LAW FOR CONTEMPT OF THE COURT IN ANY OTHER MATTER.
