

(3) NOTIFY THE EMPLOYEES' REASSIGNMENT CENTER OF THE DEPARTMENT OF PERSONNEL AND THE DEPARTMENT OF EMPLOYMENT AND TRAINING OF ANY EMPLOYEES WHO ARE ADVERSELY AFFECTED.

(D) THE DEPARTMENT OF EMPLOYMENT--AND--TRAINING PERSONNEL SHALL:

(1) DEVELOP A LIST OF STATE CLASSIFICATIONS WITH THEIR COMPARABLE CLASSIFICATIONS, IF ANY; AND

(E) THE DEPARTMENT OF EMPLOYMENT AND TRAINING SHALL DEVELOP A PROGRAM TO ASSIST ADVERSELY AFFECTED STATE EMPLOYEES BY PROVIDING RETRAINING AND OTHER APPROPRIATE EMPLOYMENT AND TRAINING SERVICES.

{E} (F) THE SECRETARY OF PERSONNEL AND THE SECRETARY OF EMPLOYMENT AND TRAINING SHALL ADOPT RULES AND REGULATIONS TO IMPLEMENT THIS SECTION.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1984.
