that purpose, by a general law which in its terms and its effect applies alike to all similarly classified municipal corporations, the General Assembly hereby expressly authorizes all municipal corporations in this State within the class created by purpose of financing article for the the construction, establishment, extension, alteration or acquisition of adequate storm drainage systems, [and] for the purpose of the design, acquisition, establishment, improvement, financing extension, operation or alteration of public parking facilities, pedestrian malls, [and] for the purpose of financing the acquisition, erection, construction, improvement design, maintenance of street and area lighting, AND FOR THE PURPOSE-OF FINANCING-PROMOTION,-DEVELOPMENT,-AND--COORDINATION--OF--BUSINESS AND--COMMERCE PURPOSES SET FORTH IN SECTION 2(B)(35) OF THIS their respective ARTICLE, to create within corporate taxing districts for these purposes and to levy on all real and personal property located within these special taxing districts an ad valorem tax at a rate sufficient to provide adequate annual revenues to pay the principal and interest on any bonds or other obligations of the municipality issued for these purposes as the principal and interest become due, and to pay the of operating and maintaining these facilities AND ACTIVITIES. These taxes shall be levied in the same manner, upon the same assessments, for the same period or periods, and as of the same date or dates of finality as are now or may hereafter be prescribed. '
