- (3) [In Harford County board members shall be appointed by the county executive with the advice and consent of -1-the County Council] THE--HARFORD--COUNTY--DELECATION--TO--THE MARYLAND--CENERAL--ASSEMBLY:---THE-COUNTY-EXECUTIVE-SHALL-PRESENT THE-PROPOSED-APPOINTMENTS-TO-THE-DELECATION-30--DAYS--BEFORE--THE BEGINNING-OF-THE-MEMBERS'-TERMS:--THE-DELECATION-SHALL-ACT-ON-THE PROPOSED-APPOINTMENTS-WITHIN-15-DAYS:--IF-THE-DELECATION-DOES-NOT ACT;--THE--APPOINTMENTS--ARE--FINAL--ON--THE--16TH--DAY:---IF-THE DELECATION-REJECTS-A-PROPOSED-APPOINTMENT;-THE--COUNTY--EXECUTIVE SHALL--PRESENT-ANOTHER-PROPOSED-APPOINTMENT-TO-BE-ACTED-ON-BY-THE DELECATION-WITHIN-5-DAYS:
- (I) NOMINEES SHALL BE SELECTED FOR VACANCIES ON THE HARFORD COUNTY LIQUOR CONTROL BOARD WITH CONSIDERATION GIVEN TO GEOGRAPHICAL REPRESENTATION.
- ON THE HARFORD COUNTY LIQUOR CONTROL BOARD IS AS FOLLOWS:
- LIST OF NOMINEES TO THE HARFORD COUNTY DELEGATION TO THE MARYLAND GENERAL ASSEMBLY FOR THEIR ADVICE AND CONSENT. THE LIST SHALL CONTAIN A MINIMUM OF 3 NAMES FOR EACH VACANCY AND BE PRESENTED 60 DAYS PRIOR TO THE OCCURRENCE OF THE VACANCY;
- 2. WITHIN 7 WORKING DAYS FROM THE RECEIPT OF THE LIST FROM THE COUNTY EXECUTIVE, THE HARFORD COUNTY DELEGATION SHALL CONSENT BY APPROVING THE NOMINEES OR BY DELETING NAMES FROM THE LIST OF NOMINEES. IF THE DELEGATION FAILS TO ACT ON THE LIST WITHIN THE 7 WORKING DAY PERIOD, ALL OF THE NOMINEES ARE, BY OPERATION OF THE LAW, AUTOMATICALLY CONSENTED TO AS ORIGINALLY SUBMITTED BY THE COUNTY EXECUTIVE;
- OF THE LIST THAT WAS ACTED UPON BY THE DELEGATION, THE COUNTY EXECUTIVE MAY REPLACE ANY NOMINEE THAT WAS DELETED BY THE DELEGATION AND MAY RESUBMIT THE LIST FOR DELEGATION APPROVAL IN ACCORD WITH SUBPARAGRAPH 2, OF THIS PARAGRAPH;
- 4. THE COUNTY EXECUTIVE SHALL SUBMIT 1 OF THE NOMINEES FOR EACH VACANCY TO THE COUNTY COUNCIL FOR ITS ADVICE AND CONSENT.
- (j) In case of a vacancy on an appointive board for any reason whatever, it shall be filled for the unexpired term in the same manner as the original appointment; except that in Worcester County the vacancy shall be filled by the Governor with the advice and consent of the Senate[, and in Harford County the vacancy shall be filled by the county executive with the advice and consent of the County Council].
- SECTION 2. AND BE IT FURTHER ENACTED, That 2 members shall be appointed to the Harford County liquor control board in August, 1984. Of the 2 members appointed in 1984, the term of the first member shall expire on the first Monday in April, 1986;
