

{4} (6) WHERE A REFUND HAS BEEN REQUESTED, THE DATE THE REFUND WAS MADE;

{5} (7) THE NAME, ADDRESS, AND AMOUNT OF COMPENSATION PAID TO EACH SOLICITOR; AND

{6} (8) THE DATES ON WHICH PAYMENTS WERE MADE TO EACH SOLICITOR.

(M) A PROFESSIONAL SOLICITOR SHALL MAINTAIN FOR A PERIOD OF NOT LESS THAN 3 YEARS AFTER THE COMPLETION OF EACH FUND-RAISING DRIVE, CAMPAIGN, OR EVENT, RECORDS WHICH SHALL ACCURATELY REFLECT ALL COMPENSATION RECEIVED FOR SERVICES RENDERED AND ALL FUND-RAISING EXPENSES INCURRED. A PROFESSIONAL SOLICITOR SHALL OPEN THE RECORDS TO THE SECRETARY OF STATE FOR REVIEW AND REPRODUCTION AT ANY HEARING CALLED BY THE SECRETARY OF STATE.

(N) A PROFESSIONAL SOLICITOR SHALL PROVIDE THE SECRETARY OF STATE, WITHIN 3 MONTHS FROM THE END OF EACH FUND-RAISING DRIVE, CAMPAIGN, OR EVENT, AN ACCOUNTING, UNDER OATH, OF ALL FUNDS RECEIVED AND DISBURSED ON A GROSS BASIS ON FORMS PRESCRIBED BY THE SECRETARY OF STATE. THE PROFESSIONAL SOLICITOR AND AN AUTHORIZED OFFICIAL OF THE CHARITABLE ORGANIZATION FOR WHICH THE PROFESSIONAL SOLICITOR IS SOLICITING CONTRIBUTIONS SHALL SIGN THE ACCOUNTING AND CERTIFY THAT IT IS TRUE TO THE BEST OF THEIR KNOWLEDGE.

(O) (1) A PROFESSIONAL SOLICITOR MAY NOT REQUEST, DEMAND, OR RECEIVE AS COMPENSATION FOR FUND-RAISING SERVICES TO A CHARITABLE ORGANIZATION A TOTAL AMOUNT IN EXCESS OF ± 30 PERCENT OF THE TOTAL MONEYS, PLEDGES, OR OTHER PROPERTY RAISED OR RECEIVED BY REASON OF ANY SOLICITATION ACTIVITY, DRIVE, CAMPAIGN, OR EVENT, INCLUDING REIMBURSEMENT FOR EXPENSES INCURRED.

(2) FOR PURPOSES OF THIS SECTION, THE TOTAL MONEYS, FUNDS, PLEDGES, OR OTHER PROPERTY RAISED OR RECEIVED SHALL BE COMPUTED BY FIRST DEDUCTING THEREFROM THE ACTUAL COST TO THE CHARITABLE ORGANIZATION OR PROFESSIONAL SOLICITOR OF GOODS SOLD OR SERVICES PROVIDED TO THE PUBLIC IN CONNECTION WITH THE SOLICITING OF CONTRIBUTIONS, AND THE ACTUAL COSTS OF THE PREPARATION OF FINANCIAL REPORTS.

(A) A PERSON MAY NOT ACT AS A SOLICITOR FOR A PROFESSIONAL SOLICITOR ENGAGED BY A CHARITABLE ORGANIZATION UNLESS THAT PERSON HAS FIRST REGISTERED WITH THE SECRETARY OF STATE. APPLICATIONS FOR REGISTRATION SHALL BE IN THE FORM AND CONTAIN SUCH INFORMATION AS MAY BE PRESCRIBED BY THE SECRETARY OF STATE, AND SHALL BE UNDER OATH. THE APPLICATION FOR REGISTRATION BY A SOLICITOR OR RENEWAL OF REGISTRATION SHALL BE ACCOMPANIED BY AN ANNUAL FEE OF \$25.
