- (6) "PROGRAM" MEANS THE CRITICAL AREA PROTECTION PROGRAM OF A LOCAL JURISDICTION INCLUDING ANY AMENDMENTS TO IT.
- "PROJECT APPROVAL" MEANS THE APPROVAL (7) OF DEVELOPMENT, OTHER THAN DEVELOPMENT BY A STATE IN THE CHESAPEAKE BAY CRITICAL AREA BY THE GOVERNMENT AGENCY. APPROPRIATE LOCAL APPROVAL AUTHORITY. THE TERM INCLUDES APPROVAL OF SUBDIVISION PLATS AND SITE PLANS; INCLUSION OF AREAS WITHIN ISSUANCE OF VARIANCES, SPECIAL EXCEPTIONS, AND ZONES; CONDITIONAL USE PERMITS; AND ISSUANCE OF BUILDING ZONING PERMITS. THE TERM DOES NOT INCLUDE BUILDING PERMITS.
- (B) WHEREVER THIS SUBTITLE REQUIRES MONTSOMERY-OR PRINCE GEORGE'S COUNTY TO EXERCISE ANY POWER OR AUTHORITY IT SHARES WITH THE MARYLAND-NATIONAL CAPITAL PARK AND PLANNING COMMISSION, THE OBLIGATION IMPOSED BY THIS SUBTITLE RESTS ON BOTH THE COUNTY AND THE MARYLAND-NATIONAL CAPITAL PARK AND PLANNING COMMISSION IN ACCORDANCE WITH THEIR RESPECTIVE POWERS AND AUTHORITIES.
