WILLFULLY DESTROYS, CUTS, BREAKS, OR REMOVES any tree, plant or shrub within-[its]-THE-limits-OF-ANY-PUBLIC--OR--PRIVATE IN ANY CEMETERY OF IN THIS STATE, or who shall be guilty of indecent or disorderly conduct within said limits, shall be guilty of a misdemeanor, and [upon conviction thereof in any court of competent jurisdiction of this State,] shall-ON-CONVICTION:

- (C) Nothing in this section shall be construed to prohibit the removal of the remains of any human body, or of any monument, gravestone or other marker from an abandoned cemetery, provided that the prior consent in writing of the State's attorney of the county or of Baltimore City shall have been secured and provided further that such remains, monuments, gravestone or other marker is placed in an accessible place in a permanent cemetery.
