Article 15A - Budget and Fiscal Planning Section 40 Annotated Code of Maryland (1981 Replacement Volume and 1983 Supplement)

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article 15A - Budget and Fiscal Planning

40.

- (A) IN THIS SECTION, "COMMITTEE" MEANS THE STATE DONATIONS OVERSIGHT COMMITTEE.
  - (B) THERE IS A STATE DONATIONS OVERSIGHT COMMITTEE.
  - (C) THE COMMITTEE CONSISTS OF:
- (1) 3 MEMBERS OF THE HOUSE OF DELEGATES, APPOINTED BY THE SPEAKER OF THE HOUSE;
- (2) 3 MEMBERS OF THE SENATE, APPOINTED BY THE PRESIDENT OF THE SENATE;
  - (3) 2 MEMBERS APPOINTED BY THE GOVERNOR;
- (3) (4) THE STATE COMPTROLLER, OR THE COMPTROLLER'S DESIGNEE; AND
- (4) (5) THE SECRETARY OF BUDGET AND FISCAL PLANNING, OR THE DESIGNEE OF THE SECRETARY OF BUDGET AND FISCAL PLANNING.
- (D) (1) THE HEAD OF ANY UNIT OF THE STATE GOVERNMENT MAY SUBMIT TO THE COMMITTEE A LIST OF ANY PROGRAMS OR PROJECTS FOR WHICH PRIVATE FUNDS ARE NEEDED TO SUPPLEMENT THE GENERAL OR FEDERAL FUNDS APPROPRIATION FOR THE PROGRAMS OR PROJECTS.
- (2) THE LIST SHALL BE ACCOMPANIED BY A DESCRIPTION OF ANY PROMOTIONAL EFFORTS IN EFFECT THAT ARE INTENDED TO PERSUADE CITIZENS OF THE STATE TO MAKE DONATIONS TO ANY PROGRAM OR PROJECT.
- (3) PROMOTIONAL EFFORTS MAY NOT CONFLICT WITH THE FUND-RAISING EFFORTS OF ANY PRIVATE FUND-RAISING ORGANIZATION.
- (E) SUBJECT TO THE FOLLOWING CRITERIA, THE COMMITTEE SHALL SELEGT-ANNUALLY CERTIFY ANNUALLY BY JULY 1 THOSE PROGRAMS OR PROJECT FOR WHICH THE STATE SHALL USE THE INCOME TAX INFORMATION BOOKLETS TO SOLICIT PRIVATE DONATIONS:
