(A)-(1)--THE-COMMITTEE-SHALL-PROVIDE-THE--PROMULGATING--UNIT
AND--THE--DIVISION--OF-STATE-DOCUMENTS-WITH-WRITTEN-NOTICE-OF-ANY
RECOMMENDED-SUSPENSION-OF-A-REGULATION.

(2)--THE-NOTICE-SHALL-CONTAIN-A-BRIEF--EXPLANATION--OF
THE-GROUNDS-FOR-THE-RECOMMENDED-SUSPENSION.

(B)--IF-THE-COMMITTEE-FAILS-TO-PROVIDE-WRITTEN-NOTICE-OF-ANY
RECOMMENDED--SUSPENSION--TO-THE-PROMULGATING-UNIT;-THE-REGULATION
SHALL-BE-CONSIDERED-APPROVED.

(C)--A-RECOMMENDED-SUSPENSION-HAS-THE-EFFECT-OF--PROHIBITING

(A)--ON---RECEIPT---OF---WRITTEN--NOTICE--OF--A--RECOMMENDED
SUSPENSION;-THE-UNIT-PROPOSING-THE-REGULATION--MAY--WITHDRAW--THE
REGULATION-OR-ANY-POR-TION-OF-THE-REGULATION-AT-ISSUE.

(B)--IF--THE-PROMULGATING-UNIT-WITHDRAWS-THE-REGULATION;-THE
UNIT-SHALL-ADVISE-THE-COMMITTEE-OF-ITS-DECISION-IN-WRITING.
