

CHAPTER 278

(House Bill 1675)

AN ACT concerning

Cecil County - Special Tax District

FOR the purpose of creating, making provision for, and generally relating to the Octoraro Lakes Special Taxing District in Cecil County.

BY adding to

The Public Local Laws of Cecil County
Section 4B-1 through 4B-6 4B-5 to be under the new chapter
"Chapter 4B. Octoraro Lakes Special Taxing District"
Article 8 - Public Local Laws of Maryland
(1970 Edition and December, 1982 Supplement, as amended)

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article 8 - Cecil County

CHAPTER 4B.

OCTORARO LAKES SPECIAL TAXING DISTRICT

4B-1.

THERE IS AN OCTORARO LAKES SPECIAL TAXING DISTRICT WITH BOUNDARIES AS FOLLOWS:

BEGINNING FOR THE SAME AT A POINT AT OR NEAR TO THE CENTER OF THE ROAD LEADING FROM NEW BRIDGE TO ROCK SPRING, AND VERY NEAR THE INTERSECTION OF THE SAID CENTERLINE WITH THE CENTERLINE OF AN UNIMPROVED ROAD CALLED ROUP ROAD, THE SAID BEGINNING BEING THE NORTHERLYMOST CORNER OF THAT WHOLE TRACT CONVEYED BY AND DESCRIBED IN A DEED FROM BURNIE GOUGE TO WILLIAM H. DONAGHUE AND VIOLET E. DONAGHUE, HIS WIFE, DATED JANUARY 23, 1956, AND RECORDED AMONG THE LAND RECORDS OF CECIL COUNTY IN LIBER W.A.S., NO. 24, FOLIO 158, THENCE LEAVING THE AFORESAID ROAD FROM NEW BRIDGE TO ROCK SPRINGS AND BINDING ON OR NEAR ROUP ROAD, SOUTH 75 DEGREES 12 MINUTES 00 SECONDS WEST 650.00 FEET TO A PIPE HERETOFORE SET; THENCE LEAVING THE ROAD AND RUNNING SOUTH 12 DEGREES 51 MINUTES 47 SECONDS EAST 194.94 FEET TO A TREE STANDING AT A FENCE CORNER; THENCE RUNNING SOUTH 63 DEGREES 37 MINUTES 05 SECONDS WEST 267.52 FEET TO A CORNER POST; THENCE RUNNING SOUTH 44 DEGREES 00 MINUTES 41 SECONDS EAST 392.66 FEET TO A POST STANDING AT THE CORNER OF A WOODS; THENCE RUNNING SOUTH 17
