

SUBCOMMITTEE OF THE BOARD IN ACCORDANCE WITH SUBSECTION (B) OF THIS SECTION.

(D) ANY NONPROFIT HEALTH SERVICE PLAN THAT HAS A PREMIUM INCOME FOR THE PRECEDING YEAR OF LESS THAN \$30,000,000 IS EXEMPT FROM THIS SECTION.

(E) THE PROVISIONS OF THIS SECTION DO NOT APPLY TO AN ANY EXISTING FOREIGN NONPROFIT HEALTH SERVICE PLAN UNTIL JULY 1, 1987 1989.

438C.

(A) ANY INSURER PROVIDING HOSPITAL BENEFITS IN THIS STATE THAT OFFERS BENEFITS TO AN INSURED OR BENEFICIARY WHO UTILIZES CERTAIN DESIGNATED LOW-COST HOSPITALS, DIFFERENT FROM THE BENEFITS OFFERED FOR UTILIZATION OF OTHER HOSPITALS, SHALL BASE ITS DESIGNATION OF A LOW-COST HOSPITAL ON INFORMATION WHICH:

(1) EXCLUDES THE REASONABLE COST OF MEDICAL EDUCATION AS DETERMINED BY THE HEALTH SERVICES COST REVIEW COMMISSION;

(2) EXCLUDES THE REASONABLE COST OF UNCOMPENSATED CARE AS DETERMINED BY THE HEALTH SERVICES COST REVIEW COMMISSION; AND

(3) EXCLUDES ANY HOSPITAL FROM CONSIDERATION THAT IS DETERMINED BY THE HEALTH RESOURCES PLANNING COMMISSION TO BE A SOLE COMMUNITY PROVIDER;

(4) EXCLUDES THE AMOUNT IN RATES AS APPROVED BY THE HEALTH SERVICES COST REVIEW COMMISSION FOR UNDERGRADUATE NURSING EDUCATION;

(4) (5) EXCLUDES THE COST, AS DETERMINED BY THE HEALTH SERVICES COST REVIEW COMMISSION, ASSOCIATED WITH---

(i) ANY SHOCK TRAUMA FACILITY;--OR

(ii)--ANY-SPECIALTY-CARE-UNIT, AND

(3) (5) (6) COMPARES HOSPITALS ON A REGIONAL BASIS UNLESS THE INSURER DEMONSTRATES TO THE SATISFACTION OF THE INSURANCE COMMISSIONER THAT A STATEWIDE COMPARISON IS MORE APPROPRIATE UNDER THE CIRCUMSTANCES.

(B) AN INSURER PROVIDING HOSPITAL BENEFITS UNDER SUBSECTION (A) OF THIS SECTION MAY NOT SUBSIDIZE THESE BENEFITS FROM PREMIUMS EARNED BY OTHER BENEFIT PLANS OR POLICIES.

(A) ANY INSURER PROVIDING GROUP HEALTH INSURANCE OR BLANKET HEALTH INSURANCE IN THIS STATE THAT OFFERS BENEFITS TO AN INSURED OR BENEFICIARY WHO UTILIZES CERTAIN DESIGNATED LOW-COST
