Preamble

WHEREAS,--Maryland-has-enjoyed--for-countless-years,--the-rich tradition-of-thoroughbred-racing,--and

WHEREAS,--Maryland's-racing-and-breeding-industries-generate nearly-one-billion-dollars-annually-and-employ-19,000-people,--and

WHEREAS,--The-revitalization-of-this-industry-and--assistance in--helping--it--meet-the-challenge-of-increased-competition-from neighboring-states-is-in-the-best-interest-of-the-general-welfare and-econome-health-of

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

Article 78B - Racing Commission

(a)--Any--person--er--persons,--association--or--corperation, desiring-to-conduct-racing-within-the-State--of--Maryland--during any--calendar-year,--shall-apply-to-the-Maryland-Racing-Commission for-a-license-se-to-de. --Such-application-shall-be-filed-with-the {secretary} EXECUTIVE-DIRECTOR-of-the-Commission-en-er--before--a day--to--be--fixed--by--the--Commission. ---Such-application-shall specify-the-days-on-which-such-racing-is-desired-to-be--conducted er--heid,--and--such-application-shall-be-in-such-form-and-supply such-data-and-information-as-the-said-Maryland-Racing--Commission shall-prescribe.

(b)--Said--Racing--Commission-shall,--as-soon-as-practicable, award-all-dates-for-racing-in-the-State-of-Maryland-en-er--before December-1-of-each-year-for-racing-for-the-ensuing-year. --The-said dates--se-awarded-shall-not-exceed-{one-hundred-and-eighty-(180)} 216-days. --The-Commission-{in-its-discretion-en-er--before-December 1-of-each-year}-may-also-award-an-additional--{forty-eight--(48)} 80--days-for-racing-for-the-ensuing-year. --{Said-forty-eight-(48)} THE-80-days-of--racing--may--be--awarded--under--such--terms--and conditions--as--the--Commission-may-prescribe-for-any-substantial alterations,--additions,--changes,--improvements-or-major-repairs-to er-upon-the-property-owned-or-leased-by-any-licensee--and--by-it used--for--the--conduct--of--racing. ---The--Commission--may--also prescribe-terms-and-conditions--with--respect--to--the--location, capacity,--availability-and-improvement-of-parking-facilities-as-a requirement--for--the--award-of-the-{forty-eight-(48)}-80-days-of
