{b}--Each--mile--thoroughbred--licensee--licensed--under--§--7--of this--article--shall--deduct--the--breakage--computed--to--the--10--cents and--the--following--amounts--on--all--races--conducted--by--it--{for calendar--year--1983--and--all--subsequent--calendar--years,}--17--percent of--the--regular--mutuel--pool,--19--percent--of--the--multiple--mutuel pool--involving--two--horses,--and--25--percent--of--the--multiple--mutuel pool--involving--three--or--more--horses. --Regular--mutuel--pool--means--a separate--wagering--pool--in--which--an--interest--is--represented--by--a single--ticket--evidencing--a--single--wager--on--one--horse. --Multiple mutuel--pool--means--a--separate--wagering--pool--in--which--an--interest is--represented--by--a--single--wager--on--two--or--more--horses. --Each licensee--shall--apply--the--amounts--deducted--as--follows:

{1}--One--half--of--the--breakage--shall--be--allocated--for purse--money. --Ten--percent--of--the--one--half--of--the--breakage--for purse--money--shall--be--allocated--to--the--Maryland--Bred--Race--Fund--as provided--by--§--18A--of--this--article.

{2}--One--half--of--the--breakage--may--be--retained--by--the licensee. }
