(a) In addition to the other grounds specified in Subtitle 1 of this title for refusal, suspension, or revocation of a license, the Administration may refuse to grant a license under this subtitle to any person and may suspend, revoke, or refuse to renew the license of any person if it finds that the person has:

(1) MADE ANY MATERIAL MISREPRESENTATION IN TRANSFERRING A VEHICLE TO A DEALER;

[(1)] (2) Failed to comply with any written warranty agreement; or

[(2)] (3) Failed to reasonably compensate any franchised dealer who does work under;
