

(A) SUPPORT ORDERS ISSUED OUT OF STATE SHALL BE ENFORCED IN THE SAME MANNER UNDER THIS PART III OF THIS SUBTITLE AS SUPPORT ORDERS ISSUED IN THIS STATE.

(B) A RECIPIENT OF AN OUT-OF-STATE SUPPORT ORDER OR--AN ~~OUT-OF-STATE-SUPPORT-ENFORCEMENT-AGENCY~~ MAY FILE A MOTION REQUEST FOR SERVICE OF AN EARNINGS WITHHOLDING ORDER UNDER § 10-123 OF THIS SUBTITLE BY SUBMITTING THE INFORMATION REQUIRED UNDER § 10-123 OF THIS SUBTITLE, AND A CERTIFIED SUPPORT ORDER OR A SUPPORT ORDER REGISTERED IN THIS STATE.

(C) (1) A RECIPIENT OF AN OUT-OF-STATE SUPPORT ORDER OR--AN ~~OUT-OF-STATE--SUPPORT-ENFORCEMENT-AGENCY-MAY~~ MAY REQUEST THAT THE SUPPORT ENFORCEMENT AGENCY FILE WITH THE COURT A MOTION REQUEST FOR SERVICE OF AN EARNINGS WITHHOLDING ORDER UNDER § 10-123 OF THIS SUBTITLE BY SUBMITTING A MOTION REQUEST FOR SERVICE, A CERTIFIED SUPPORT ORDER, AND A ~~NOTARIZED~~ STATEMENT OF ARREARS UNDER OATH.

(2) A REQUEST UNDER THIS SUBSECTION MAY BE SUBMITTED BY THE RECIPIENT OR AN-~~OUT-OF-STATE~~ A SUPPORT ENFORCEMENT AGENCY.

IN THE CASE OF AN OUT-OF-STATE OBLIGOR OR OUT-OF-STATE EMPLOYER, THE ~~COURT~~ SUPPORT ENFORCEMENT AGENCY SHALL, UPON RECEIPT OF A MOTION REQUEST FOR SERVICE OF AN EARNINGS WITHHOLDING ON THE ACCRUAL OF 30 DAYS SUPPORT ARREARS, SEND TO THE APPROPRIATE STATE AGENCY OR COURT A REQUEST FOR EARNINGS WITHHOLDING AND ANY INFORMATION AND FEES REQUIRED BY THAT STATE TO PROCESS THE REQUEST.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1985.

AN ACT concerning

Foreign Corporations - Federal Credit Unions
