- establishment issued within one (1) year from the date of expiration or revocation of a prior license provided the revocation did not result from acts of the owner of the establishment.
- (B) (1) IN THIS SUBSECTION, "TAKOMA PARK TRANSIT IMPACT AREA" MEANS THE TAKOMA PARK TRANSIT IMPACT AREA AS APPROVED AND ADOPTED IN THE SECTOR PLAN FOR TAKOMA PARK, MONTGOMERY COUNTY, MARYLAND.
- (A) OF THIS SECTION, THE MONTGOMERY COUNTY BOARD OF LICENSE COMMISSIONERS BY UNANIMOUS VOTE MAY APPROVE AN ALCOHOLIC BEVERAGES LICENSE OF AN APPLICANT FOR A RESTAURANT ESTABLISHMENT WHICH IS LOCATED ON LAND CLASSIFIED IN OR NEAR A CBD ZONE (CENTRAL BUSINESS DISTRICT ZONE), OR NEAR-A-GBD-ZONE IN OR NEAR THE TAKOMA PARK TRANSIT STATION-DEVELOPMENT-AREA-ZONE IMPACT AREA, IF THE FOLLOWING CONDITIONS ARE SATISFIED:
- (+) (1) (+) 1. IF THE RESTAURANT BUILDING IS OUTSIDE A CBD ZONE OR THE TAKOMA PARK TRANSIT STATION-DEVELOPMENT-AREA ZONE IMPACT AREA, THE MEASUREMENT OF THE DISTANCE OF THE NEAREST POINT OF THE RESTAURANT BUILDING TO THE NEAREST BOUNDARY LINE OF A CBD ZONE OR THE TAKOMA PARK TRANSIT -STATION-DEVELOPMENT-AREA ZONE IMPACT AREA IS 500 FEET OR LESS; OR
- (##) 2. THE RESTAURANT BUILDING IS ENTIRELY CONTAINED IN LAND CLASSIFIED IN A CBD ZONE OR THE TAKOMA PARK TRANSIT STATION-DEVELOPMENT-AREA-ZONE IMPACT AREA;
- (2) (II) THE ISSUANCE OF THE REQUESTED LICENSE WILL NOT ADVERSELY AFFECT NEARBY SCHOOLS, CHURCHES, YOUTH CENTERS OR THE NEAREST RESIDENTIAL COMMUNITY; AND
- (3) (III) EXCEPT FOR THE DISTANCE RESTRICTIONS PROVIDED IN SUBSECTION (A) OF THIS SECTION, THE RESTAURANT OTHERWISE QUALIFIES UNDER THIS ARTICLE FOR THE ISSUANCE OF THE LICENSE REQUESTED.
- (4) (2) (3) ANY LICENSE ISSUED UNDER THIS SUBSECTION (B) AUTHORIZES ITS HOLDER TO KEEP FOR SALE AND SELL ALCOHOLIC BEVERAGES FOR CONSUMPTION ON THE PREMISES ONLY.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1985.
