(L) (1) A NATIONAL FAMILY WINE EXHIBITION PERMIT MAY BE ISSUED AT THE DISCRETION OF THE COMPTROLLER TO A BONA FIDE--NATIONAL FAMILY WINE ASSOCIATION.

{ii}--WINE---ASSOCIATION,----OR----LOCAL---WINE ASSOCIATION,--OR

{iii}--WINE-SOCIETY,--OR-LOCAL-WINE-SOCIETY.

(2) THE PERMIT HOLDER MAY CONDUCT A NATIONAL FAMILY WINE EXHIBITION, JUDGE AND OR--TASTE--THE-WINE COMPETITION OF FAMILY-PRODUCED-WINE.

{3}--THE-PERMIT-HOLDER-MAY--RECEIVE--TAX--FREE--FAMILY PRODUCED--WINE--AND--COMMERCIALY--PRODUCED,--TAX-PAID,--WINES-FROM MARYLAND--LICENSED--FROM--WHOLESALEERS,--ON--BEHALF--OF---MARYLAND LICENSED-NONRESIDENT-DEALERS,--MANUFACTURERS,--OR-SUPPLIERS-AND-MAY RECEIVE--COMMERCIALY--PRODUCED--WINE--FROM--NONMARYLAND-LICENSED MANUFACTURERS-OR-SUPPLIERS-SUBJECT-TO-THE-TAX-IMPOSED-IN--SECTION 133-OF-THIS-ARTICLE.

(3) THE PERMIT HOLDER MAY RECEIVE FOR USE, EXHIBITION, AND TASTINGS AT A NATIONAL FAMILY WINE EXHIBIT:

(I) TAX FREE FAMILY PRODUCED WINE;

(II) TAX PAID COMMERCIALY PRODUCED WINES FROM LICENSED NONRESIDENT DEALERS OR MANUFACTURERS THROUGH LICENSED MARYLAND WHOLESALEERS OR LICENSED CLASS 4 WINERIES; AND

(III) COMMERCIALY PRODUCED WINE FROM NONMARYLAND LICENSED MANUFACTURERS OR SUPPLIERS SUBJECT TO THE TAX IMPOSED IN SECTION 133 OF THIS ARTICLE.

(4) A NONRESIDENT DEALER'S PERMIT SHALL NOT BE REQUIRED FOR OF A NONMARYLAND LICENSED SUPPLIER FOR SHIPMENT OF WINE TO A NATIONAL FAMILY WINE EXHIBITION PERMITEE NOR--SHALL SECTION-4(H)-OF-THIS-ARTICLE-APPLY.

(5) THE PERMIT HOLDER MAY NOT SELL BUT MAY EXHIBIT, JUDGE, AND TASTE,--AND--OTHERWISE-UTILIZE THE PRODUCE WINE ACQUIRED PURSUANT TO THIS SECTION IN-ANY-MANNER,--EXCEPT-FOR-SALE, AT THE PLACE DESIGNATED IN THE APPLICATION FOR A PERIOD NOT EXCEEDING 5 DAYS.

(6) MANUFACTURERS, NONRESIDENT DEALERS, SUPPLIERS, AND WHOLESALEERS OR THEIR REPRESENTATIVES MAY ACT AS JUDGES OR MAKE--PRESENTATION PARTICIPATE AT A NATIONAL FAMILY WINE EXHIBITION.
