{1}--THE--DELAY--AND--A--NEW--ESTIMATED--DELIVERY--DATE,--AND

{2}--IF--THE--DELIVERY--IS--NOT--MADE--WITHIN--30--DAYS--AFTER--THE--NEW--DELIVERY--DATE,--THE--CUSTOMER--MAY:

{I}--CANCEL--THE--CONTRACT--AND--RECEIVE--A--FULL--REFUND,

{II}--CANCEL--THE--CONTRACT--AND--RECEIVE--A--CREDIT--FROM--THE--DEALER--EQUAL--TO--THE--CONTRACT--PRICE,

{III}--NEGOTIATE--WITH--THE--DEALER--A--NEW--DELIVERY--DATE,--OR

{IV}--MODIFY--THE--CONTRACT--BY--SELECTING--OTHER--FURNITURE--OR--ANOTHER--MAJOR--HOUSEHOLD--APPLIANCE--OF--COMPARABLE--PRICE--TO--THE--CONTRACT--PRICE.

{F}--{1}--IF--A--CONSUMER--CANCELS--A--CONTRACT--DUE--TO--A--DELAY--IN--DELIVERY--AND--REQUESTS--A--FULL--REFUND--OR--CREDIT,--THE--DEALER--SHALL--RETURN--TO--THE--CONSUMER--THE--FULL--REFUND--OR--CREDIT--WITHIN--2--WEEKS--OF--THE--CONSUMER'S--REQUEST.
