

OF NOTICE OF SALE, WHICH SHALL BRIEFLY OUTLINE SAID TERMS AND CONDITIONS IN ACCORDANCE WITH THE PROVISIONS HEREOF. SAID NOTICE SHALL STATE, AMONG OTHER THINGS, SUCH MATTERS AS ARE REQUIRED TO BE STATED IN THE NOTICE REQUIRED TO BE PREPARED IN CONNECTION WITH A PUBLIC SALE OF ANY GROUP OR SERIES OF BONDS PURSUANT TO THE PROVISIONS OF THE IMMEDIATELY PRECEDING PARAGRAPH, PROVIDED THAT THE COUNTY SHALL BE REQUIRED TO PROVIDE IN THE NOTICE ONLY SUCH INFORMATION ABOUT THE CURRENT FINANCIAL CONDITION OF THE COUNTY AS IT SHALL DETERMINE TO BE APPROPRIATE UNDER THE CIRCUMSTANCES, UPON ADVICE OF LEGAL COUNSEL AND UPON ADVICE OF THE COUNTY'S FINANCIAL ADVISOR, IF ANY, OR SHALL INDICATE IN THE NOTICE WHERE SUCH INFORMATION MAY BE OBTAINED. THE COUNTY SHALL DETERMINE IN SUCH RESOLUTION THE METHOD FOR DISTRIBUTING SUCH NOTICE, THE PARTIES TO WHOM SUCH NOTICE SHALL BE DELIVERED, AND SUCH OTHER MATTERS CONCERNING THE OFFERING OF THE BONDS ON A LIMITED BASIS AND THE NOTICE PERTAINING THERETO AS THE COUNTY SHALL DEEM APPROPRIATE, UPON ADVICE OF LEGAL COUNSEL AND UPON ADVICE OF THE COUNTY'S FINANCIAL ADVISOR, IF ANY. THE COUNTY SHALL NOT BE REQUIRED TO MAKE ANY GENERAL PUBLICATION OF SUCH NOTICE.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June 1, 1985 .
