

NEWSPAPERS FOR AT LEAST 2 WEEKS BEFORE THE HEARING IS HELD. THE FINAL BUDGET SHALL BE ADOPTED BY A RESOLUTION APPROVED BY THE COMMISSIONERS.

(C) BY THE TIME OF THE FIRST NOTICE OF PUBLIC HEARING, THE PROPOSED COUNTY BUDGET SHALL BE FILED WITH THE CLERK OF THE COUNTY COMMISSIONERS AND BE AVAILABLE FOR PUBLIC INSPECTION. ONE COPY SHALL BE SUPPLIED TO EACH NEWSPAPER OF GENERAL CIRCULATION IN THE COUNTY AND TO EACH BRANCH OF THE COUNTY LIBRARY AND COPIES SHALL BE MADE AVAILABLE TO THE PUBLIC AT OR BELOW COST.

#### 5-103. SUBSEQUENT BUDGET CHANGES.

(A) THE COMMISSIONERS MAY CHANGE AN ADOPTED BUDGET ONLY BY RESOLUTIONS THAT COMPLY WITH THIS SECTION, THE MARYLAND CONSTITUTION, STATE LAWS OR PUBLIC LOCAL LAWS. CHANGES MAY NOT BE SUBDIVIDED TO ALTER THE APPLICABILITY OF THE REQUIREMENTS OF THIS SECTION.

(B) THE COMMISSIONERS BY RESOLUTION MAY ESTABLISH PROCEDURES FOR THE ADMINISTRATIVE REORGANIZATION-OR-CONSOLIDATION OF THE VARIOUS FUNDS INCLUDED IN THE COUNTY BUDGET, THE TRANSFER OF APPROPRIATIONS BETWEEN GENERAL CLASSIFICATIONS OF EXPENDITURES IN THE CURRENT EXPENSE BUDGET WITHIN THE SAME OFFICE OR DEPARTMENT, INTERPROJECT TRANSFERS OF APPROPRIATIONS BETWEEN CAPITAL PROJECTS IN THE CAPITAL BUDGET, AND THE ADDITION OF NEW BUDGET ITEMS. HOWEVER, ONLY CHANGES INVOLVING LESS THAN \$10,000 \$5,000 EACH MAY BE MADE UNDER THIS SUBSECTION.

(C) TRANSFERS OR ADDITIONS INVOLVING AN AMOUNT OF \$10,000 \$5,000 OR MORE, OR TRANSFERS BETWEEN DEPARTMENTS, AGENCIES, BOARDS, OR COMMISSIONS MAY BE MADE ONLY BY RESOLUTION APPROVED BY THE COMMISSIONERS.

(D) ANY CHANGE INVOLVING FUNDS TOTALING MORE THAN \$100,000 \$50,000 MAY BE MADE ONLY BY RESOLUTION APPROVED BY THE COMMISSIONERS AFTER COMPLIANCE WITH THE PUBLICATION AND HEARING REQUIREMENTS APPLICABLE TO THE ORIGINAL PROPOSED BUDGET.

(E) TO MEET A PUBLIC EMERGENCY AFFECTING LIFE, HEALTH, OR PROPERTY, THE COMMISSIONERS BY RESOLUTION MAY MAKE EMERGENCY APPROPRIATIONS FROM CONTINGENT OR SURPLUS FUNDS.

#### SUBTITLE 2. PERMITTED APPROPRIATIONS.

##### 5-201.

ALL APPROPRIATIONS MADE UNDER THIS SUBTITLE SHALL COMPLY WITH THE PROVISIONS OF SUBTITLE 1 OF THIS TITLE.

##### 5-202. CALVERT MEMORIAL HOSPITAL.

THE COUNTY COMMISSIONERS MAY APPROPRIATE A SUM IN AN AMOUNT TO BE DETERMINED BY THEM TO THE CALVERT MEMORIAL HOSPITAL.
