

(B) MEMBERS SHALL BE MASTER PLUMBERS WHO HAVE RESIDED AND BEEN ENGAGED IN THE PLUMBING BUSINESS IN CALVERT COUNTY FOR AT LEAST 3 YEARS PRECEDING THEIR APPOINTMENT.

(C) TERMS OF MEMBERS SHALL BE FOR 2 YEARS AND MEMBERS APPOINTED TO FILL VACANCIES OCCURRING DURING ANY TERM SHALL HOLD OFFICE FOR THE UNEXPIRED PORTION OF THAT TERM.

(D) THE GOVERNOR MAY REMOVE ANY MEMBER OF THE BOARD FOR INCOMPETENCY OR IMPROPER CONDUCT UPON SATISFACTORY PRESENTATION OF EVIDENCE OF THAT CONDITION.

9-203. SAME; COMPENSATION.

THE COUNTY SHALL PAY THE EXPENSES OF THE BOARD THAT ARE APPROVED BY THE COUNTY COMMISSIONERS, AND SHALL PAY EACH MEMBER \$50 FOR EACH MEETING OF THE BOARD THE MEMBER ATTENDS.

9-204. RULES AND REGULATIONS.

THE BOARD SHALL ADOPT REGULATIONS THAT SPECIFY THE SETTING OF FEES, THE EXAMINATION OF APPLICANTS, AND THE BUSINESS OF PLUMBING IN CALVERT COUNTY, WHICH SHALL BE EFFECTIVE ONLY AS APPROVED BY THE COUNTY COMMISSIONERS. PROPOSED REGULATIONS SHALL BE PUBLISHED IN AT LEAST 2 COUNTY NEWSPAPERS FOR 2 CONSECUTIVE WEEKS. THE COMMISSIONERS SHALL PROVIDE FOR A PUBLIC HEARING ON PROPOSED REGULATIONS AND SHALL PUBLISH NOTICE OF THE HEARING WITH THE PROPOSED RULES.

9-205. FEES PAID TO COUNTY.

ALL FEES COLLECTED UNDER THIS SUBTITLE SHALL BE PAID TO THE COUNTY.

9-206. LICENSE REQUIRED; EXCEPTIONS.

(A) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBTITLE OR THE REGULATIONS OF THE BOARD, AN INDIVIDUAL SHALL HOLD A CURRENT LICENSE ISSUED BY THE BOARD BEFORE EITHER ENGAGING IN THE BUSINESS OF PLUMBING IN CALVERT COUNTY OR REPRESENTING THAT THE INDIVIDUAL IS AUTHORIZED TO ENGAGE IN THAT BUSINESS.

(B) UNLICENSED INDIVIDUALS MAY ENGAGE IN THE BUSINESS OF PLUMBING IN CALVERT COUNTY ONLY TO THE EXTENT PERMITTED BY THE REGULATIONS OF THE BOARD AND ONLY IF THE WORK IS DONE UNDER THE DIRECTION AND SUPERVISION OF A MASTER PLUMBER, WHO SHALL BE RESPONSIBLE FOR ALL WORK DONE.

(C) ANY FIRM OR CORPORATION THAT IS ENGAGED IN OR ABOUT TO ENGAGE IN THE BUSINESS OF PLUMBING IN CALVERT COUNTY SHALL REGISTER WITH THE BOARD AND PROVIDE THE INFORMATION THE BOARD REQUIRES.
