(2)--The--professional--and--clerical-employees--of--the--Enoch-Pratt-Free--library--of--Baltimore--City,--except--for--employees-described--in--subsection--(4)--of--this--section,--are--included--in--the-definition--of--"teacher"--as--that--term--is--defined--in--paragraph--(3)--of--§--81--of--this--subtitle--for--and--in--connection--with--any--and--all--of--the--terms--and--provisions--of--§--89--(4)--of--this--subtitle.
