- UNLESS THE MOBILE SEAFOOD VENDOR HAS WRITTEN PERMISSION OF THE OWNER OF THE SHOPPING CENTER AND CONFORMS TO APPLICABLE LOCAL LAWS AND ORDINANCES;
- (5) (4) BESS-THAN-15-YARDS WITHIN A-SAFE AN UNSAFE DISTANCE, AS DETERMINED BY THE LOCAL AUTHORITIES, FROM THE EDGE OF ANY ROADWAY;
 - (6) (5) ON ANY ROADWAY; OR
- ### (6) EXCEPT-AS-PERMITTED-UNDER-\\$-24-303--0F--THIS SUBTITE; ON PRIVATELY OWNED PROPERTY ADJOINING A STATE HIGHWAY, UNLESS THE MOBILE SEAFOOD VENDOR OWNS, LEASES, OR HAS WRITTEN PERMISSION OF THE OWNER OF THE PRIVATELY OWNED PROPERTY.
